### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

NLoL serves homeless single adults and families. Priority is given to chronically homeless single adults and chronically homeless families. There are 4 one-bedroom apartments located in one building that has a total of 12 units. Participants are encouraged to stay in the apartment as long as needed and have no definitive exit date. Support services are provided on-site by a case manager (CM). CM is responsible for identifying necessary referrals and connecting program participants (PPs) to necessary services in the community as well as assisting the PPs in integrating into the community. The CM is also responsible for educating PPs on the housing market and providing general housing counseling. The housing counseling includes education about how to find housing in the Golden Triangle area, how to maintain housing, and housing rights. PPs develop a case plan with the end goal being either taking over the lease OR moving out to FMR housing of their choosing. At exit, NLoL ensures that the new housing option fits their new phase in life and works best with either new employment or educational pursuits. For participants with disabilities who are unable to work, program participation consists of helping head of household achieve life skills so that they are able to live independently on their fixed income. Program graduates are allowed to take with them any of the furniture they were given in the apartment. Participation with CM and other service providers is encouraged so that the needs assessed at intake are met during their participation in this program. Sobriety and /or compliance with a treatment plan is not required, but tenants are expected to maintain the requirements of a standard apartment lease. Income is not required at entry, but all tenants are expected to work towards obtaining a source of income once housed. NLoL works closely with the local mental health providers, education providers, and employment services providers to connect program participants with necessary assistance to meet treatment plans and assist all members of the household. CM also assesses need for things like parenting classes, financial classes, and other life skills training and refers program participant as needed. A case plan might also include basic budgeting skills and household management. If the head of household has been paying 30% of income toward monthly rent for a period of 3 months, the CM works with the household to start making assessments as to whether the household is ready to graduate out of NLoL. It is explained to all PPSs that it is recommended that housing cost never be more than 30% of household income. This is the yard stick that is used before ever considering recommending that a PP graduate from the program, as well as assessing the head of household has achieved a living wage when the case manager is helping the household work on budgeting.
