3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Multi- County Community Service Agency, Inc. proposes to implement a Permanent Supportive Housing RRH project to provide housing relocation and stabilization services with short-term rental assistance, medium-term not to exceed 12 months which is necessary to help homeless families. We will use a Housing First approach in helping people access and sustain permanent affordable housing quickly. This project will target homeless families with children under the age of 18 assisting them in attaining and maintaining permanent housing. Annually serving sixty (60) families in our nine county service area with concentration being on Lauderdale, Newton and Clarke Counties. Specific supportive services to be provided will be case management, employment assistance with job training, child care, transportation, life skills training, moving cost, utility deposits, housing search and counseling services. Assistance will be provided to program participants who meet the criteria under the homeless definition according to HUD. All referrals will be pre-screened using VI-SPDAT entering data in Foothold Technology. In accordance with housing relocation and stabilization requirements we will provide short-term rental assistance for up to three (3) months to thirty-five (35) families. Medium-term rental assistance for up to six months to twenty-five (25) families, n(not to exceed 12 months) with all participants being reviewed monthly on a case-by-case basis. This will be a tenant-based project (scattered sites) where rental properties are to be identified by the participant or case management. All Units must be approved for leasing by MCCSA staff after a Habitability Standards inspection checklist with determination that the property meets HUD standards. Landlords will sign a rental assistance agreement on behalf of the head of household naming the terms of agreement, monthly rent for the unit, due date and the amount for late fees. Rental assistance and deposits will be paid by MCCSA directly to the landlord. All housing must be within the FMR for that county.
