We will utilize RRH dollars to move them into permanent housing and will continue to provide supportive services. Supportive services will include counseling, group counseling, childcare, Vocational, medical and transportation.

Recovery House will also use these funds to house those coming out of Safe Haven (domestic violence shelter), from the streets and referrals from Last House on the Block, Columbus Housing Authority, Community Counseling Services, City of Columbus, United Way and other agencies within the Golden Triangle.

This project will serve individuals and families with Housing First approach. We will provide both short term and medium term combined with supportive services to quickly rehouse those individuals.
