3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

ASC PH will provide rapid rehousing assistance to help individuals exit homelessness and enter permanent housing. This program will be offered with minimum barriers to ensure that preconditions do not hinder client participation. Three core components will, as with all RRH, be critical to success: housing identification, rent and moving assistance, and case management and supportive services to help clients maintain their housing and acquire services they need. Relationships with potential landlords must be established and maintained. Supportive services will be the glue that helps keep clients attached to their housing. Through its participation in the MS Balance of State coordinate entry system or CES, ASC has seen that a number of homeless do not have an appropriate housing opportunity locally. This is currently a gap in services in our community that, in order to truly work toward functionally ending homelessness, must be filled. The street and woods homeless will comprise the clients that will be served by the project. Through the 2017 PIT for the Balance of State, we learned that more than 33% of the homeless population within the Balance of State's 72 county area reside in the Pine Belt region, ASC's primary target area. Thirty-five (35%) per cent of those counted were unsheltered. Individuals with serious mental illness and the chronically homeless made up the highest number of unsheltered in the CoC.
