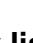

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

This RRH project aided the BOS CoC in achieving an effective end to Veteran homelessness as recognized by the USICH in the fall of 2018. Furthermore, the program will serve as an integral part of the CoC’s newest goal of effectively ending chronic homelessness in the BOS CoC in 2020. The RRH program will continue to be a low barrier, Housing First program and MUTEH will continue to strengthen community ties to promote and secure stability. Using the Coordinated Entry System (CES) for program entry, the proposed grant is client-centered and follows each client’s preference from intake to discharge. MUTEH focuses on meaningfully engaging, housing, and stabilizing participants by:

- #1 Outreach-- all clients served by MUTEH’s RRH program are identified through unsheltered or sheltered outreach across the BOS as a part of the CoC’s CES. As an agency, MUTEH leads these intensive street/encampment outreach teams and carries partner agencies from a variety of disciplines to allow for real-time referrals. So, as individuals are identified during street outreach, they are directly connected to the BoS CES and handed off to the most appropriate service (according to their choice). Individuals/families who are referred to MUTEH’s CoC RRH program are first screened/documentated for eligibility; then they are immediately connected to the case management team.
- #2 Housing Search and Placement- The housing search is based on the client’s choice using the tenant-based rental assistance model. It takes the average household 30 days to move into permanent housing from program admission. MUTEH also works with Public Housing Authorities to get homeless preferences for disabled and chronically homeless individuals in their communities. The Housing Team not only works with local landlords to access affordable housing, but they also work with local furniture banks to ensure that clients have furniture and basic housing needs when they move in.
- #3 Case Management (CM) - the CM process is guided by the client, and is continually offered to every client in the program. The case manager works in coordination with the Housing Team and Outreach Team to allow CM to start as soon as possible. MUTEH utilizes the Critical Time Intervention (CTI) case management model as each client is provided an individualized housing stabilization plan. The CTI model involves 9-months of case management at different levels of intensity. During the first 3 months, the case manager provides intensive services as a direct advocate for clients - connecting them to housing, employment, and mainstream benefits. In the following quarter, clients are taught to utilize community resources and how to maintain stable housing and employment, which allows clients to advocate for themselves. In the final phase, the case manager has established the person in the community as they are in full control — with MUTEH providing ongoing case management as needed.



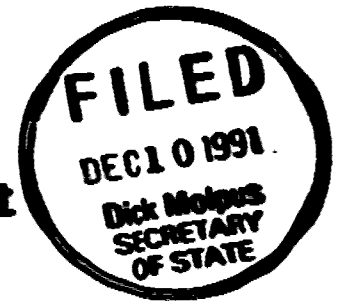

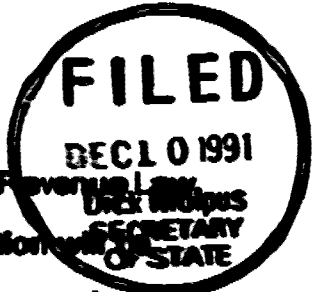

- 6. This corporation is a charitable nonprofit organization within the meaning of Section 79-11-101, et seq, Code of Mississippi of 1972.**

In the event of dissolution, the residual assets of the organization shall be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code or to the federal, state, or local government for exclusive public purpose.
