

V. COC APPLICATION APPEALS PROCESS:

- 1. MS Balance of State Governing Council discussed the Appeals Process. This is a continuing issue from the previous Governing Council meeting.
- 2. APPEALS PROCESS Background– Three of the agencies with projects in Tier 2 applied for a ranking appeal. The Governing Council discussed the precedent that was set for past application cycles and what options the GC has for creating a new appeals policy. With documentation from October 2014 to present the precedent the MS Balance of State COC Governing Council has for ranking appeals is that an agency can only appeal the ranking process, and not the numerical ranking itself. The current appeals document is out of date an needs to be updated. M. Mitternight, executive committee chair, weighted in and said that the Ranking Committee is comprised of members of the Governing Council and that the ranking decision that they determine should be upheld unless gross negligence within the ranking process is determined. It was decided by the GC that the appeals process needs to be proactively updated not reactively.
- 3. It was suggested by members of the Governing Council that the appeals process of other Balance of State COCs would be the appropriate next step in the continuing discussion of examining the appeals process.
- 4. MSBOSCOC Director consulted HUD Technical Assistance and they offered examples of other COCs appeals Process
 - 1. Riverside California COC Awards Protest
 - 2. Similar to MSBOSCOC Current Policy in which only the ranking and review process can be appealed not the numerical ranking of projects in Tier 1 and 2
