



 - 2. Navigators are participating in outreach to assist the CoC in identifying clients.
 - 3. CES is practicing reporting that will give more feedback to CoC agencies in the System.
 - 2. Concerns
 - 1. Referrals are being distributed, but not engaged.
 - 2. Messages (AWARDS) are not being opened.
 - 3. Follow-up Phone calls are not being answered.
 - 4. Agencies are not Practicing Priority.
- 4. CES Referral Dashboard
 - 1. Logistics:
 - 1. Regional Referral Dashboard for each region
 - 2. Managed by the regional Navigator and CES Director
 - 3. Client status is managed by Navigator communication with Agencies

- 4. Only referred clients for the agency show up on the dashboard.
- 5. Once the client is housed (or otherwise), Navigator moves the client off and a new referral is made
- 2. Benefits:
 - The CoC and Lead Agency can focus on outreach while agencies focus on housing our vulnerable population. (Agencies with outreach funding are still encouraged to do outreach as well.)
 - 2. The Navigators can focus on referral communication and priority for the CES.
 - 3. Navigators and Agencies can communicate to understand the CES process and client housing status within the system.
 - 4. Agencies focus on housing viable, certified homeless clients.
 - 5. Agencies can access referrals easily without concern for email security or sifting through AWARDS messages for communication about client follow-up.
- 5. CES News and Notes:
 - 1. Conducting 2nd interviews to hire a new CES Navigator for the Pine Belt.
 - 2. Street Outreach Mobile App Submissions
 - CoC requested proposals in developing or procuring a mobile application to assist with street outreach efforts across the BoS. This mobile app must also have the capability to interface with or export to HMIS.
 - 2. Submissions from: Bitfocus, Simtech, Fingent Corp.
 - 3. Proposals to be reviewed at the next HMIS Committee Meeting [TBA].










In Smartsheet, referrals are made to regional dashboards. Navigators are able to see lists, housing status and make changes to the dashboard.



Agencies are able to click a link to the dashboard to see referrals and housing status. Once referred, agencies can take referrals from HMIS WL into program.
