3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Isaac Newton once said, “we build too many walls and not enough bridges,” and that has been true with homeless service data in years past. As the HMIS lead agency, MUTEH has striven to include all homeless shelter data in its HMIS system which has further bolstered the CES implementation. However, in recent years, as outreach efforts have further developed and small rural communities have launched additional shelters, rural CoC’s are seeing the walls of data silos rising once more.

Agency staff attempted to rise to this challenge as it had in the past through mentoring relationships (with newfound agencies) and by allowing HMIS participation to sell itself as a primary step to data informed operations. These efforts produced genuine responses, from those emergency shelters, and commitments to participate. The HMIS team trained staff, set up the necessary programming in HMIS, and continued to monitor agency participation. But, the data collection continually stalled with rural shelters across the BOS CoC. Agencies listed many reasons for their inability to follow through – staff turnover, lack of staff time, and/or the inability to fill vacant positions.

In the spirit of Sir Isaac Newton, MUTEH is excited to renew the DataBridge to CES grant. This grant will pay for 3 FTE’s across the CoC coverage area to bridge rural emergency shelters with the CoC HMIS system and the CES. The DataBridge initiative will begin with the intense, initial step of DataBridge staffers directly entering shelter data into the HMIS system. This will immediately result in compliance with HMIS standards within the CoC and timely data available for the CES. But, this initial step in compliance/capacity is not the final vision – the goal will be that the DataBridge staffers will guide shelter staff into HMIS compliance sustained solely by the shelter agency. We understand that past attempts implemented a timeline that was too aggressive and lacked the capacity-building elements necessary for long term success. It will take time for rural shelters to experience the benefits, and relative ease, of HMIS participation. Therefore, each DataBridge staff person will work with the HMIS team to craft an implementation plan customized for each rural shelter. The plans will consider historic challenges faced by the surrounding community and the marginalized populations within it. This should allow for an equitable plan that fosters a spirit of diversity and inclusivity in its approach. This initiative is not only for the community but will be driven by the community. Rural communities and minority groups have suffered from the building of too many walls. It is time to connect necessary programs to these populations that have gone without them for too long. The DataBridge to CES is the answer.

The System Administrator and HMIS Vendor are responsible for implementing privacy and security standards for all HMIS users and participating agencies. Finally, the HMIS Lead agency employed a CoC Compliance Director that serves as an additional layer of review for said purposes.

- Housing Fees. Grant funds can be used to pay fees associated with getting survivors into a safe unit via emergency transfer(s), including but not limited to application fees, broker fees, holding fees, trash fees, pet fees where the person believes they need their pet to be safe, etc.
- Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).
- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.



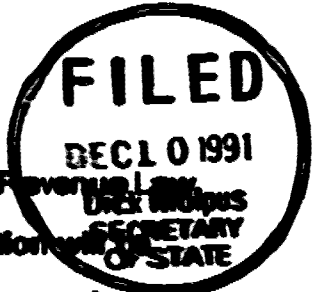
