2. SYSTEM PERFORMANCE MEASURES, PART II

- a. **The First 4 SPMs – March 2024:** In March, M. Baliko began a series of talks on the BoS improving our capacity to meet and surpass our current standards in

meeting HUD's System Performance Measures (SPMs). The first 4 measures discussed were:

- i. Length of Time Persons Experience Homelessness
- ii. The Extent to which Persons Who Exit Homelessness to Permanent Housing Destinations Return to Homelessness within 6, 12, and 24 months.
- iii. The number of persons Experiencing Homelessness
- iv. Employment and Income Growth for the Homeless Persons in the CoC Program-funded Projects

b. The Last 3 SPMs

- i. Number of Persons Who Become Homeless for the First Time
- ii. Homeless Prevention and Housing placement of persons defined by category 3 of HUD's Homeless Definition in CoC Program-funded projects.
- iii. Successful Placement from street outreach and Successful Placement in or retention of permanent housing

3. COALITION MEMBERSHIP – is defined by the following criteria.

- a. Participating in Coordinated Entry: including Outreach, Intake, Waitlist, and Access to Housing
- b. Utilizing HMIS: Appropriately and Consistently Using HMIS
- c. Attending Meetings/Training: Includes regional coalition meetings, CoC Annual Meetings, and CoC-Led Training

4. PROGRAM QUESTION OF THE MONTH

- a. When should a client receive a MOVE-IN DATE?
 - i. ANSWER: The day the client moves into a permanent living situation.
