The Mississippi Balance of State Continuum of Care (MSBOS CoC) Collaborative Applicant, Mississippi United to End Homelessness (MUTEH) will utilize the planning grant funds in order to implement the Responsibilities of the COC as outlined in 24 CFR 578.7. These responsibilities include designating and operating an HMIS, Continuum of Care operation and planning, and developing a VAWA emergency transfer plan. MUTEH, as the collaborative applicant, will employ a CoC Director that will be responsible for implementing the operations of the MSBoS under the direction of the Governing Council. CoC operations include holding member meetings in all five geographic regions of the MSBoS; the meeting agendas include training and dialogue on timely and important issues that are occurring within the CoC. MUTEH will also employ a staff member that will evaluate and monitor the COC and ESG-funded projects. Any findings identified during monitoring will be reported to the CoC Director. The planning grant will allow the CoC Director and GC to continually review the Coordinated Entry System Monthly Metric Analysis Reports (MMA), and Annual Performance Analysis Reports from CES funded staff. This will be reported to the MSBoS GC to ensure the system continues to implement procedures that include assessing homeless individuals and families and prioritizing those with the most need. As the collaborative applicant, MUTEH will implement the MSBoS CoC Written Standards as established by the GC. Written Standards include policies and procedures on client eligibility evaluation, prioritization for individuals and families that receive transitional housing assistance, determination and prioritization for eligible families and individuals that receive rapid rehousing assistance, the amount of rent each rapid rehousing project participant will be responsible for, determination and prioritization for eligible families and individuals that receive permanent supportive housing assistance. MSBoS Written Standards also include standards and best practices for case management, street outreach, rapid resolution/diversion, supportive services, homelessness prevention, emergency shelters, drop-in centers, and inter-agency collaboration. As the collaborative applicant and HMIS lead agency, MUTEH will implement a single HMIS system for the MSBoS while monitoring compliance with the comparable databases of Victim Service Providers. MUTEH will perform the MS BOS CoC planning activities, which include performing outreach efforts throughout the MS BoS 71 county service area and an annual Point-In-Time count. MUTEH will also create a gap analysis of homeless needs and services available and will provide necessary information to complete a consolidated plan within the MS BOS CoC coverage area. Lastly, as the Collaborative Applicant, MUTEH will continue to implement a VAWA emergency transfer plan for the MS BoS that meets requirements under § 578.99(j)(8)

The requested funds will be used to employ a Compliance Specialist to evaluate and monitor the CoC and ESG-funded projects. Any findings identified during monitoring will be reported to the CoC Director and in a report to the GC. The Compliance Specialist will complete monitoring visits to review regulatory compliance of CoC and ESG-funded projects. The Compliance Specialist will inform projects funded through the CoC on a timely basis of their weaknesses and suggest tools to improve performance. The Mississippi Balance of State CoC will consult with the ESG recipient regarding the performance of ESG-funded projects in order to create a holistic service network between ESG and CoC funding. This compliance monitoring will confirm that both CoC and ESG-funded providers are fulfilling HUD's vision of their funding while maintaining communication with local funders to guarantee they are also aware of their recipients' performance.
